



NOTICE OF NOMINATION MEETING

March 11th, 2026 at 10:00 AM

Elders Hall – One Arrow First Nation

NOTICE IS HEREBY GIVEN that a meeting of the Eligible Electors of One Arrow First Nation, will be held at the Elders Hall on March 11, 2026, beginning at 10:00 am and lasting until 1:00 pm, for the purpose of nominating candidates for one (1) position for Chief and eight (8) positions for Councillor, followed by the Candidate's Forum.

The Election of the Chief and Councillors will be held on March 27, 2026.

PLEASE NOTE that any Eligible Elector may nominate only one (1) Candidate for the Chief's position and one (1) Candidate for a Council position at the nomination meeting.

Any Eligible Elector may run in the election for the position of Chief or Councillor.

An Eligible Elector may be a candidate in the Election if they:

1. Have not been convicted of a Prescribed Offence in the five (5) years prior to the date of the Election and have **included a Criminal Record Check** from the RCMP or similarly reputable authority and do not stand charged with a Prescribed Offence as of the Nomination Meeting.
2. Hold a Class 5 Drivers' License that is not suspended as of the Nomination Meeting as evidenced by a **current driver's abstract**.
3. Submit and do not fail a **Fit for Duty Test**, at the Nomination Meeting.
4. Have not been removed from office pursuant to Article 16 of the *One Arrow First Nation Customary Election Act, 2024* in the term immediately preceding the election.
5. Are **not an employee of the Nation**, a Nation Entity or an Affiliated Entity, and subject to Section 18.2, of the Act, and do not otherwise engage in a work-for-pay arrangement with the Nation, a Nation Entity or an Affiliated Entity, or have taken a leave of absence, from their employment or other work for pay arrangement from the time of nomination and remain on leave until after Election Day.

To be Eligible to run in the Election, Candidates must be in attendance at the Nomination Meeting, with their nominators and must accept their nomination.

Please be advised that the Electoral Officer will require Eligible Electors (Candidates and Nominators) to **present Government-Issued ID** such as Drivers' License or Status Card and execute the Declaration Form In the presence of the Electoral Officer.

In addition to the evidence of eligibility, Candidates will be required to provide a **certified cheque or money order** payable to One Arrow First Nation, at the Nomination Meeting. The non-refundable nomination fee is \$500 for Chief and \$250 for Councillor.

The Candidates Forum will be held in person and start at 1:00 pm on March 11, 2026 at the Elders Hall. Nominators may give a two (2) minute speech and each candidate may address the assembly for ten (10) minutes.

In order to vote in this Election, Electors must be eighteen (18) years of age and older as the date of the Election, registered as Members of One Arrow First Nation, and on the Voters List. The Act, Voters List and forms and information are available at <https://uElect.ca>. Electors who do not appear on the Voter's List must contact the Chief Electoral Officer as soon as possible.
